Introduction and Context

- **Kerry Community Council** is a rural community council with a population of circa 2300 in a predominantly livestock- based farming area and covers the three villages of Kerry, Sarn and Dolfor, an area of 88.4 sq.km. Our precept for 2024/2025 was £33,871.00
- **Currently we have 13 councillors** and employ a part time Clerk, a part time RFO and a part-time playground caretaker.
- **A fund- raising group** runs a popular Fun Day in Kerry every August and Dolfor has an annual show with animal, craft and produce sections
- **We own and manage Kerry cemetery**: Kerry village public conveniences: Dolforan Park with its LEAP: a LAP at Herbert Court, Kerry and an NEAP at St. Michael's Primary School, Kerry.
- **We maintain our war memorials.**
- **The current biodiversity officer was appointed in 2024** and a further councillor joined them in May 2025 to form a supportive cohesive team to tackle biodiversity issues for the council.

	-raise awareness of biodiversity & its importance	BEE event (Biodiversity Engagement Event)– along with other councils that are members of VMRC Kerry held its first BEE event. It was held in June 2024 and another is planned for June 2026. There were lots of stalls & activities including homes for insects, making fat-balls for bird-feeding, birdfeeders, there was a pollinator friendly plant swap, beekeeping, hedgehog awareness and preservation, turning unwanted t-shirts into shopping bags, curlew preservation. A large bug hotel was built from pallets and will be permanently sited in the churchyard. Attendees were invited to attach a “leaf” to the “Tree of Pledges” having added a personal pledge of intent to do or change one small thing which would assist the natural world to thrive.. 2	-safeguard principal species and habitats	The river Mule continues to be monitored. The riverbank near the bridge in Dolforgan Park was suffering from considerable bank erosion. Initial work was done late 2024/early 2025 by a small team of councillors. Further work was carried out in the summer of 2025 taking advantage of the very dry spring/summer, when the riverbed ran dry. The river Mule feeds into the River Severn at Abermule and was only sustained by tributaries further downstream near Glanmule. Even then the river flow was very low. A number of the trees in Dolforgan Park have had tree preservation orders for many years.	All Councillors
3	-restore & create habitats and resilient ecological networks	The butterfly garden in the cemetery has continued to thrive with a small team of volunteers caring for it.	Biodiversity Officer
4	-tackle negative factors: for e.g. reduce pollution, use nature based solutions, address invasive species	Apart from the air pollution from the A489 which the council has no control over, dog pollution appears to be the main issue. Dog bins are provided and owner offenders are reprimanded on social media by other residents, sadly	



		<p>there is little else we can do about this at present.</p> <p>Reducing our carbon footprint - Solar panels were installed on the roof of the KCC toilet blocks in August 2024 ensuring they were powered by a non-polluting renewable source.</p> <p>Invasive species- There is currently no evidence of invasive species, if Himalayan Balsam should be spotted growing along the riverbank a removal will need to be organised.</p>

Review of S6 duty actions for 2023-2025

What has worked well?	<p>Our 2024 BEE event promoted public engagement with the concept of biodiversity. Hands on participation educated individuals through the principle of learning by doing and having fun at the same time. This is particularly important as we feel our best strategy is to engage with the younger members of the community who can then in turn communicate the biodiversity message to older family members. The emphasis is on small individual projects being important because they all add up and result in overall improvement in biodiversity. No effort however small is wasted eg. One birdfeeder or one bee-hotel in a garden is better than nothing.</p>
What have the barriers been?	<p>Public engagement – adequate publicity for the event so as many people attend or us to get the message across.</p>
What will you change?	<p>Improve the level of communications. By engaging directly with St. Michaels (C in Wales) primary school in Kerry (Sarn and Dolfor have no state schools). There is a private faith school in Sarn but they appear to operate an exclusivity policy and they are also relocating out of Powys, in the near future. There is also Brynllwarch school for ALN pupils . This school is currently in the process of being rebuilt on a new site and when completed KCC will be able to involve them with our future plans.</p>
How and when will the s6 duty be monitored and the s6 plan reviewed?	<p>The biodiversity team will annually review our progress including feedback from our next BEE event in June 2026.</p>
