# Name of Town or Community Council: Kerry Community Council

### **Introduction and Context**

Kerry Community Council provide a range of services to its local community which have an impact on biodiversity. These include:

- Responsibility for a number of green spaces: Dolforgan Park and Herbert Court, plus the Kerry Cemetary
- Responsibility for the public conveniences in Kerry, which directly impacts on the resiliance of local ecosystems, through water and energy management
- Funding we give grants for projects in the Council's area. This impacts on biodiversity through cascading funding criteria.

We promote sustainability and biodiversity by pursuing sustainability goals and sustainable practices whenever possible. The Council is a member of the Vale of Montgomery Cluster Group and supports its work on footpaths.

We serve approximately 1600 residents. The precept for 2019-20 is £28,228.
