## **9. APPROVAL OF MINUTES FROM 8<sup>TH</sup> APRIL, 2024:**

## **10. BRETT KIBBLE – FOOTPATH PROJECT UPDATE:**

The draft version of the Community Liaison (Public Access) Partnership constitution/memorandum, was discussed and it emerged that nothing has been formerly agreed between councils. Berriew noted they have a footpath committee, AwL stated they need to take this issue back to full council to discuss further. The project using sets of volunteers works on clearing footpaths and installing gates and stiles and signposting. Under officer P. Johnson lot of work has been done in the last eighteen months. PCC's role is to provide backup in the form of insurance, training and tools. The PCC officer working with the project can facilitate agreements with land owners. No agreements in place means no work can be done. At the start of the scheme in 2018 PCC believed an agreement was in place. Pre-covid a lot of work was done including lots of repairs and establishing circular routes but not SO much has been done since Covid.

The VMRC footpath workload for 2024 was circulated. Community councils have this work done for nothing. 15-20 stiles or bridges were installed and 2 circular walks were established in the Abermule area.

Following on from Brett's sharing of information various points were raised

- An updated version of the agreement documentation is imperative for moving forward, Cllr. J Rees and Cllr G Jones stressed this issues importance.
- The VMRC insurance situation is not clear and needs sorting out since PCC recruits the volunteers.
- AwL felt strongly liaising with landowners must be done ahead of work commencing by PCC, workers liaising with owners on the day could pose a safety for workers. Cllr. G Jones was particularly concerned about this point as she pointed out that some landowners were very anti any use of their land for public footpaths.

It was **AGREED** that going forward that it was ***imperative*** all agreement documentation was updated.

## **11. BIG NATURE EVENT 30<sup>TH</sup> JUNE:**

LLANDYSSIL –Run single handedly by Cllr. G. Jones. Cllr. Jones reported that this went well, plenty of posters had been distributed. Activities included a delicious picnic in the church and a visit to Cllr. Jeremy Brignell-Thorpe's property where uses for old and new wooden pallets were shown. Growing of potatoes/runner/herbs was also explained. Twenty water bottles at £3 each were sold the proceeds going to support provision of clean water facilities in overseas countries.

MONTGOMERY – Took place along with the Open Gardens scheme. Events included willow-weaving and butterfly counts. Loads of positive feedback but less families than expected.

BERRIEW – Berriew event was attended by 70-80 families, the weather deterred some people and others seem to think it was only meant for children. There were plant stalls with plants for companion planting. Activities included making leaf prints and examining items such as small pond life and owl pellets contents under a microscope. A lovely atmosphere was reported with tea and cakes provided. It may be repeated in the future if more volunteers can be recruited.

KERRY/SARN/DOLFOR – KCC funded some very attractive cotton tote bags for the occasion. Taking place around the church/churchyard it was well attended by 100 + people. Refreshments

were provided in the Belltower and enjoyed by 75 +people. There lots of stalls & activities including homes for insects, making fat-balls for bird-feeding, birdfeeders, there was a pollinator friendly plant swap, beekeeping, hedgehog awareness and preservation, turning unwanted t-shirts into shopping bags, curlew preservation. A large bug hotel was built from pallets and will be permanently sited in the churchyard. An enjoyable and instructive day was had by all who attended.
